



# Wisconsin Paint Horse Club Stallion Service Auction Agreement



Return by Nov. 15, 2008 for national advertising, Dec. 1, 2008, to be included in the catalog.  
Stallions accepted up to the date of auction: 1/10/09.

### Important:

1. The SSA Futurity Committee reserves the right to refuse any stallion.
2. A stallion's service must sell to allow the stallion owner's the privilege of participating in the SSA Futurity, subject to the same rules and conditions as the mare owner.
3. Rules for the SSA Futurity are available from the Futurity Chair, or by visiting [www.wispainhorse.com](http://www.wispainhorse.com). It is each participant's responsibility to know the rules.
4. Minimum beginning auction bid is \$250, or 1/2 the usual advertised stud fee plus \$50, whichever is greater.
5. The stud fee must be your highest advertising fee for this auction year.
6. "Private Treaty" fees will start at \$250.00.
7. No "Futurity Only" specials.
8. A photocopy of the stallion's current registration papers are required as part of this agreement.
9. If a shipped semen permit is held on a stallion, shipped semen must be available for breeding(s) purchased at the auction.
10. Return breeding privileges will follow WPHC SSA Futurity rules.

### All parties to this agreement are bound to and agree to all of the following:

1. AQHA and TB stallions must be listed and in good standing with the APHA.
2. If breeding to AQHA or TB stud, mare must have APHA papers.
3. Mare must be in good condition and good health.
4. Stallion owner has the right to call a veterinarian when deemed necessary, at the mare owner's expense.
5. Stallion owner must take proper care of the mare and foal.
6. Mare owner pays board to stallion owner at advertised rates.
7. All agreements, including shipped semen, are between the mare owner and stallion owner. Wisconsin Paint Horse Club (WPHC) and Wisconsin Paint Horse Club Stallion Service Auction (SSA) Futurity act as agent only.
8. Stallion owner may require that mare owner signs Farm or Ranch breeding contract, copy of which must accompany this agreement.
9. Any additional fees to the mare owner must be provided with this agreement for inclusion in the SSA catalog.
10. WPHC does not assume liability for any disputes that may arise between the winning bidder and stallion owner.
